Please state your reasons for wanting to serve on the Commission/Board:: Three years ago I was fortunate to be able to take a break from full-time work. I went back to school to study for my Masters degree in Gerontology (study of aging). What surprised me was the sense of purpose it gave me.

First, to do whatever I can do to help others appreciate the invaluable asset our senior population can be if valued and engaged, and to do what I can to provide opportunities for engagement. I am doing that with the Vital Aging Network and the EVOLVE class that is happening right now in Roseville, but I believe that is just the beginning of what we can do in our community.

Second, belonging to a community is a very important element of healthy aging, but many people do not know what to do to become part of a community. That was me 3 years ago, but circumstances led me to join the Neighborhood and Community Engagement Task Force as a way to get involved. As a result, I went out on a limb and had the first Night to Unite party in my neighborhood. One half of the invited households came which showed me that people were looking for an opportunity to connect. About the same time, I decided to create the first Nextdoor neighborhood, and before we had even finished delivering the invitation flyers, 4 people had already signed up. 14 more neighborhoods and more than 1700 members later, this online community continues to grow.

I want to go further and do more. I want to be part of team that shares a vision and wants to explore other ideas that will strengthen our community. A team that wants to make things happen! Healthy aging? Community is healthy at every age!

What is your view of the role of this Commission/ Board?: I believe the role of the Commission is to generate ideas, and with the approval of the City Council, to turn those ideas into action. This commission is about building and strengthening relationships, between the City, the residents, and businesses.

Any further information you would like the City Council to consider or that you feel is relevant to the appointment or reappointment you are seeking.: This commission is a great addition for the City of Roseville. There are opportunities for improvement everywhere, but it takes a group of people focused on engagement to identify those opportunities and to suggest solutions.

Whether I become a commission member or not, I would suggest that the commission evaluates the commission application process. I noticed two things immediately. First, it centers around an online application, which has small boxes (with no way to know how long answers can be), and no way to save data once you start to complete it. An alternative to consider is a downloadable form, with the options for submission (email, fax, mailing address) prominently available, rather than at the end of the application. Second, the arrangement of the application questions might also be worth reviewing. An

application can be intimidating, and I imagine that starting with work history, then formal volunteer experience might be a barrier for some people, and might not be the most important considerations.
