How to Apply

Only complete applications will be accepted. ⚠️ **If an application is denied due to missing information, it will lose its place in line until all required items are submitted.**

Required Submittals:

- ✓ **Purchase Date:** Item must be purchased between July 12, 2024* – June 30, 2026.
*Applications meeting the equity criteria: Toilets must be purchased on or after July 9, 2025.
- ✓ **Completed Application Form** – signed and dated
- ✓ **Itemized Receipt (Must include ALL of the following):**
 - Purchase Date
 - Each item **listed separately** with:
 - Make and model number
 - Price of each item
 - Other fees **listed separately**:
 - Parts, disposal, etc.
 - Installation fees (must be a separate line item)
 - Proof of Payment – must show method of payment (e.g., last four digits of credit card, check number, or "Paid in Full" stamp)
- ✓ **Photo of Installed Item**

Common Mistakes to Avoid: 🚫

- ◆ **Missing model number** – Must match the qualifying list
- ◆ **Total price without item breakdown** – Each item must have its own price (installation fees, parts/disposal, make and model number, and price of each item must be separate line items)
- ◆ **Missing proof of payment** – Ensure the receipt shows how it was paid

Qualifying Items:
